- 5. Not qualified as per AICTE Norms.
- 6. Blacklisted/ Multiple Registrations.
- b. Laboratory deficiencies
 - 1. Non availability of laboratory equipment / Non working condition of laboratory.
 - 2. Lack of all supporting documents for laboratory equipment.
