INTERNSHIP AGREEMENT

This Agreement is made and executed at Hyderabad on this **15th Day of February 2021** by and between:

Ltd., a company incorporated under the provisions of the Companies Act, 1956 with CIN U72300TG2007PTC053130 having its registered office at Building No. 21, Raheja Mindspace, Survey No. 64 (part), Madhapur Village, Serilingampally Mandal, RR District, Hyderabad 500 081 (hereinafter referred to as "the Company" which expression shall mean and include its representatives, administrators, successors and assigns unless repugnant to the context herein) of the **FIRST PART**

AND
