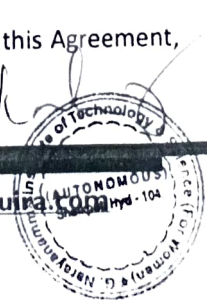
6. CETS' OBLIGATION:
