## A Committee Report to the Chairperson 8<sup>th</sup> August, 2019

**Sub:** To investigate and present the facts about the ragging issue that was brought to the notice of the Principal.

#### Committee Members:

The following six member committee was constituted to investigate and find the facts about the incident of ragging that was placed on record with the Principal:

- 1. Dr.K.Ramesh Reddy, Principal Chairperson.
- 2. Dr.K.Ramalinga Reddy, HOD, ETE, Member
- 3. Dr.B. Venkatesulu, HOD, ECE, Member
- 4. Dr.N.Malla Reddy, HOD, EEE
- 5. Dr.P.Aparna, HOD, H&M
- 6. Prof.G.Gopinath, EEE Nodal Officer, Anti Ragging.

#### Findings:

The committee members met on 7<sup>th</sup> August, 2019 in the Principal's chamber and took the briefing about the incident that took place on 3<sup>rd</sup> August, 2019 on one of the first year B.Tech student who was rounded by the 2<sup>nd</sup> Year B.Tech students and was put to a discomfort of entering into an unpleasant dialogue and conversation near the memorial.

Based on the briefing, the following 2<sup>nd</sup> Year B.Tech students were immediately summoned and questioned about the incident:

During the committee interrogation the following facts have been recorded:

- The students against the S.No. 6, 10, 11, 12, 13 and 14 were not involved with the incident and they were trespassing as the incident took place near the memorial.
- Ms. Ritvika Rao (S.No. 1) confessed that she took the photograph of the first year student and shared it with Ms. Ghuguloth Sreeharshitha (S.No.2). It is noted that both these students take the same college bus, route no. 14 E.
- Ms. Ghuguloth Sreeharshitha (S.No.2) verbally confessed that during the interaction with Ms.Rithvika the photograph was shared and she immediately posted it in her group. Later the posted photograph went viral forwarded to many other groups that went to the notice of the photographed students' parents who have taken a serious offence against it.
- The students against the S.Nos 3, 4, 5, 7, 8 and 9 were proved guilty in directly or indirectly prompting and provocating Ms.Ritvika to take the photograph and sublimely entering into one or the other dialogue with the first year student in gathering personal details and information that was shared in the social chat.
- The students against the S.Nos. 4 and 7 Ms.Naina and Ms.P.Sree Sindhuja are hostlers and have exchanged in a unparliamentary social chat. Ms. Naina's comment on the photograph of the student taken in the college dining hall is highly objectionable.
- Further Ms. Naina who is a resident of our College Hostel was found wearing a day scholar's ID.

#### Recommendations:

Based on the findings and interacting with the parents of Ms.Ritvika, Ms. Sreeharshitha, Ms.Naina and Ms. Sree Sindhuja, the committee makes the following recommendations:

- 1. Since the students against the S.Nos. 6, 10, 11, 12, 13 and 14 were found to be **NOT INVOLVED** with the incident, the committee recommends not to subject them to any action of punishment.
- 2. As the students against the S.Nos. 3, 4, 5, 7, 8, and 9 were found to be guilty being involved with the incident directly or indirectly, the committee recommends to suspend these student (Ms.KS Sankeerthan (S.No.3), Ms.CH.Naina (S.No.4), Ms.P.Nikitha (S.No.5), Ms. P.Sree Sindhuja (S.No.7) Ms.G.Sai Janvitha Reddy (S.No.8) and Ms.Pranavi.K (S.No.9)) against the incident of Ragging for ONE WEEK i.e., from 9<sup>th</sup> August, 2019 to 15<sup>th</sup> August, 2019 from the classwork.
- Based on the detailed interrogation, as Ms.Rithvika (S.No.1) and Ms.G.Sreeharshitha (S.No.2) are found to be the main culprits in getting involved with the incident, the committee recommends to suspend these students against the incident of Ragging for TWO WEEKS i.e., from 9<sup>th</sup> August, 2019 to 23<sup>rd</sup> August 2019 from the classwork.
- 4. Further, it is placed on record that Ms.CH.Naina (S.No.4) is found guilty wearing a dayscholar's ID and is found involving with the social chat in an offensive vocabulary. And Ms. P. Sree Sindhuja (S.No.7) is found guilty in sharing personal details of the first year student in the social chat. As these two students being college hostel residents, involving with such indisciplinary behavior is taken as a serious offence and the committee recommends to cancel the hostel accommodation and to look out for their individual accommodation outside the college hostel with immediate effect from 9<sup>th</sup> August, 2019.

- 1. The old Policy document was adopted for this academic year also.
- 2. Anti-Ragging committee was constituted on 22<sup>nd</sup> July 2019.
- Guidelines for conduction of Anti-ragging duties were framed on 22<sup>nd</sup> July 2019 and circulated.
- In response to the communication received from Metropolitan Legal Services authority a detailed report was prepared and dispatched on 23<sup>rd</sup> July 2019.
- The anti-ragging groups were formed as per quality policy and circulated on 3<sup>rd</sup> Aug 2019.
- In response to the findings of the AR group an enquiry committee was constituted on 7<sup>th</sup> Aug 2019
- 7. The committee submitted its report on 8th August 2019.
- Based on the recommendations of the committee 6 students were suspended for one week and 2 students were suspended for two weeks. (Circular dated: 9<sup>th</sup> August 2019.)
- Based on the oral complaint from a parent two students were suspended from the hostel (Circular dated: 9th August 2019.)
- 10. The evening anti-ragging duties went on from 5th Aug to 7th Sept. 2019.
