

### Measures taken by GNITS to curb Ragging in 1919-20

1. Constitution of anti-ragging Committee:

An anti-ragging Committee comprising faculty and students is constituted. Prof. G.Gopinath is the coordinator for this committee.

2. Formation of daily anti-ragging Squads:

Anti-ragging Squads headed by a senior faculty member were constituted which go round the campus and hostels daily from 3.30 – 5.30 pm under the supervision of Principal and Nodal officer.

3. Control of Lunch hour Ragging:

In order to minimize the interaction between the freshers and seniors, the lunch hours are staggered.

4. Counseling the senior students:

Briefing sessions were conducted by the HODs & the Anti-ragging committee members at the department level to all the senior students.

5. Undertakings from seniors:

Undertakings from all the II year students & their parents/guardians were obtained to the effect that they will not indulge in any kind of ragging activities both in the Institution as well as in the hostels.

6. Adequate publicity:

Anti-Ragging Posters depicting clauses & Punishments under Anti-Ragging Act are displayed at **all strategic points** in all the blocks of the Institution and also in the Hostels.

7. Counseling sessions for freshers:

All the classes of 1<sup>st</sup> year were addressed by the Nodal officer emphasizing the measures being **implemented** in the campus. They were informed about exclusive mail ID [arc@gnits.ac.in](mailto:arc@gnits.ac.in).

8. Isolation of freshers:


A separate hostel has been demarcated exclusively for 1<sup>st</sup> year students to minimize the interaction between the freshers and seniors.

Sub: Additional measures to curb **Ragging activities** in the campus-reg.

The HODs and Section Heads are requested to:

1. Constitute anti ragging squads with the faculty members of respective departments through an internal circular during lunch hours i.e., from 12:30 – 2:00 PM starting from 13<sup>th</sup> August to 7<sup>th</sup> September 2019. The respective areas will be:
  - CSE & ECE (Lady Faculty members) : Hostels
  - CSE & ECE (Gent Faculty members) : Krishna canteen, Open air auditorium and adjacent areas
  - Mechanical : Open ground between hostels and E-block.
  - H & M : Entire area behind Admin block including memorial
  - B&S : New Canteen and surroundings
  - ETM : Front side of Admin block up to main gate
  - EEE : EEE block surroundings and fruit juice centre and adjacent areas
  - IT : Basketball Court and adjacent roads
2. Instruct the faculty members **commuting by college buses** to be more vigilant and strict in the buses. They are expected to fully monitor and control the activities in the buses.
3. Instruct the faculty members to report at 3:45 PM sharp for evening anti ragging duties by **adjusting the class work** if any.

Sir,

With reference to above we wish to state that, GNITS has initiated several measures to ensure that the campus is free from any kind of ragging activities both in the Institution as well as in the hostels.

**We are happy to inform that NO major incidents of ragging were reported in the campus in the last few years.**

To curb the menace of ragging various committees / squads have been formed which have been monitoring the anti-ragging activities all through the working hours and even beyond.

Some of the measures taken are:

1. Constitution of anti-ragging Committee:

An anti-ragging Committee comprising both faculty and students has been constituted (Copy attached). Prof. G.Gopinath, Nodal officer-in charge is the coordinator for this committee.

2. Constitution of supporting Committees:

To augment the functioning of Anti-Ragging committee two other committees namely Hostel committee and Transport Committee were roped in to effectively check the ragging in **Hostels and College buses.**

3. Formation of daily anti-ragging Squads:

Anti-ragging Squads headed by a senior faculty member of the rank HOD/Professor were constituted which go round the campus and hostels daily from 3.30 pm – 5.30 pm under the direct supervision of Principal and Nodal officer-in charge.

The lady members of these squads visit both the hostels to ensure that everything is in order. The other members of the squad take rounds of various locations such as TSRTC Bus stops, in and around departments & Canteens, parking areas, play grounds and the lawns.

4. Counseling the senior students:

Briefing sessions were conducted by the HODs & the Anti-ragging committee members at the department level to all the senior students.

5. Undertakings from seniors:

Undertakings from all the II year students & their parents/guardians were obtained to the effect that they will not indulge in any kind of ragging activities both in the Institution as well as in the hostels (A sample undertaking form is attached).

6. Adequate publicity:

Anti-Ragging Posters depicting clauses and Punishments under Anti-Ragging Act are displayed at all strategic points in all the blocks of the Institution and also in the Hostels.

7. Isolation of freshers:

A separate hostel H1 has been demarcated exclusively for 1<sup>st</sup> year students to minimize the interaction between the freshers and seniors.

8. Surprise / random visits:

The members of the Hostel Committee are instructed to make surprise/random visits to hostels to ensure that things are in order. The members with help of the wardens will ensure a ragging free and healthy atmosphere in the hostels.

9. Able & trained Wardens:

The hostel wardens are given specific instructions to check for any kind of unwanted activities in their respective hostels from time to time.

10. Interactive sessions between juniors and seniors:

Since the first year students are yet to join the interactive sessions will be planned and executed in the month of August.

#### 11. Review meetings

Regular review meetings are being held at regular intervals by the Nodal Officer and the Principal to take stock of the developments in the Institution.

Apart from all this the Institution is firmly committed to implement any other additional measures / instructions issued by the JNTUH / AICTE / State Government from time to time.
