#### Minutes of the Third Board of Studies Meeting of B.Tech CSE (DS) Department:

- 1. Dr. M.Seetha, Board of Studies Chair, extended a cordial welcome to all the members of the Board of Studies for CSE(DS), for the Third Board of Studies Meeting of CSE(DS) Department (after attaining the UGC Autonomous Status in April 2018), and introduced all the members.
- 2. After lengthy deliberations and progressive discussions, all the Members of the Board of Studies for IT have unanimously approved
  - a. The Academic Regulations for B.Tech. Programme (with 160 Credits) in CSE(DS) Department (GNITS-2022 UG Academic Regulations), CBCS based, including NEP Exit Policy from 3<sup>rd</sup> year onwards, as per contents enclosed.
  - b. The Four Year 8 Semester UG Degree Course Structure for B.Tech. Programme in CSE(DS) Department, with a total of 160 Credits, as per contents enclosed.
