- 1. Dr. P. Rekha, BoS Chair, extended a cordial welcome to all the members of the BoS for Discipline of Management Studies and introduced all the members.
- 2. The Proposed Academic Regulations of GNITS (GNR-22 Regulations) were presented.
- 3. After discussions, all the Members of the BoS for Discipline of Management Studies have unanimously approved the GNR-22 Academic Regulations.
- 4. The Two Year 4 Semester PG Degree Course Structure for M.Tech. with a total of 68 Credits, as per contents was briefed to the members.



- 5. The BoS Committee approved the BoS Chair to present the details pertaining to Course Contents of all the Subjects/Courses related to the 2nd year of M.Tech Courses offered by Discipline of Management Studies for necessary approvals.
- 6. The Syllabus of **Business Analytics** which is offered jointly by The Discipline of Management Studies and by The Discipline of Mathematics is reorganised addressing to the needs of the industry. The suggestions offered by the members are duly incorporated. There is an overall change of 20% of the syllabus offered in this course and is approved.
- 7. The syllabus of **Cost Management of Engineering Projects** is presented with an overall change of 20% and is approved unanimously by all the members.
- 8. The chairperson profusely thanked all the members for making it convenient for the first revision proposed by GNITS as GNR-22.
