This is with reference to the proposal submitted by G. Narayanamma Institute of Technology & Science (For Women), 8-1-297/2/I, Shaikpet, Hyderabad-500 104 Telangana affiliated to JNTU Hyderabad, Telangana under the UGC Scheme for Autonomous Colleges.

On the basis of the report of the UGC Expert Committee and on the basis of the recommendations of the Standing Committee, the Commission at its meeting held on 20.03.2018 has decided to grant autonomous status to G. Narayanamma Institute of Technology & Science (For Women), 8-1-297/2/I, Shaikpet, Hyderabad-500 104 Telangana affiliated to JNTU Hyderabad, Telangana for a period of ten years w.e.f. 2018-2019 to 2027-2028.

The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.


